The El Dorado Hills Fire Department requested \$1,000 to be applied towards the purchase of new decorations for the large redwood tree on the West side of the Ramona (Moni) Gilmore Senior Center, which the Fire Department decorates during the holiday season. The Board of Supervisors approved the request for \$1,000 on October 30, 2018.

A funding agreement is required in order for the County to process the payment to the El Dorado Hills Fire Department.
