#### **DISCUSSION / BACKGROUND**

Surveyor's Office received an application from Serrano Associates, LLC, a Delaware Limited Liability Company, for an Irrevocable Offer of Dedication (IOD 18-004) for a Slope Easement on Assessor's Parcel Number 120-690-13 (Formerly 120-690-04), and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This parcel is in conjunction with the Saratoga Estates project, in El Dorado Hills on the corner of Finder's Way and Saratoga Way.

Authorization for recording said Offer is pursuant to Government Code Section 7050.
