#### **DISCUSSION / BACKGROUND**

The subject parcel is located within the master planned development of Carson Creek Specific Plan. The 30.469 acre site is identified by Assessor's Parcel Number 117-680-06 (Exhibit A) located on the south side of Carson Crossing Drive, approximately 3,000 feet south of the intersection with Golden Foothill Parkway, in the El Dorado Hills area (Exhibit B).

This Final Map for Phase 2 is the fourth map that would be recorded and developed in accordance with the Carson Creek Tentative Subdivision Map (TM06-1428-R) approved by the Planning Commission on July 9, 2015 (Item #4, Legistar 15-0761) (Exhibit D). This final map would create 143 residential lots and four lettered lots for roads and landscaping (Exhibit C).

Exhibit E details the verification of the Final Map for conformance with the approved Conditions of Approval for the Tentative Subdivision Map. County departments and affected outside agencies, including the El Dorado Hills Fire Department, Department of Transportation, and the County Surveyor's Office, have recommended approval of the map. Meter award letters from El Dorado Irrigation District have been secured for public water, recycled water, and sewer services for the subdivision (Exhibit F). The Subdivision Improvement Agreement, including associated bonds, has been approved by the Department of Transportation for Carson Creek Unit 2B Phase 2, subject to authorization by the Board Chair.

<u>Environmental Review</u>: The review of the Final Maps is a ministerial process and is Statutorily Exempt from environmental review under Section 15268(b)(3) of the California Environmental Quality Act Guidelines.
