DISCUSSION / BACKGROUND

On October 5, 2018, at the request of the Planning and Building Department, the Procurement and Contracts Division of the Chief Administrative Office issued a Request for proposal (RFP) for consultants to act in the capacity of a Code Enforcement Officer for the Community Development Services. Code Enforcement Section on an as needed basis.

The County received three proposals for the RFP. Staff is recommending that Agreements be awarded to two of the successful proposers, CSG Consultants and Willdan Engineering, each in the amount of \$60,000 for a term of three years, for a total amount of \$120,000. These contracts will help

Code Enforcement during seasonal increases in complaints (e.g. different code enforcement items have seasonal increases in complaints for different reasons like smell, weather, etc.). These contracts are in addition to two code enforcement positions that the Board approved in November.

The Board could choose not to approve the Agreements at this time; however, current Code Enforcement Services will be impacted.
