### **DISCUSSION / BACKGROUND**

Surveyor's Office received an application from C&C Saratoga Property L.L.C., for an IOD (IOD 18-0003) for a Pedestrian Easement on Assessor's Parcel Number 120-690-10, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This dedication would provide for a future sidewalk and possibly the widening of Saratoga Way. The final determination will be made by the Transportation Department during the design process for EDH Ambulatory Surgery Center project (DR 17-0003).

#### **ALTERNATIVES**

An alternative would be to not accept the IOD. By utilizing this alternative, no provision would be made for the future sidewalk as is required by the Transportation Department as Condition No. 12 of the project EDH Ambulatory Surgery Center (DR 17-0003).
