On 09/16/06 the Board of Supervisors approved Agenda item #06-1418, item #11, Resolutions #290-2006, #291-2006, #292-2006, and #293-2006 establishing an imprest cash fund (per Government Code Section 29326) for the Placerville Probation Field Office (\$50), Placerville Juvenile Hall (\$200), South Lake Tahoe Probation Field Office (\$100.00) and the South Lake Tahoe Juvenile Treatment Center (\$200); for said funds to be used to purchase services or materials which are legal charge against the County and making change when necessary in carrying out official County duties.

Reason for Recommendation:
