Probation Department recommending the Board consider the following:

3) Authorize the Purchasing Agent, or designee, to execute further documents relating to Agreement 3556 including future amendments which do not increase the maximum dollar amount or term of the agreement, contingent upon approval by County Counsel and Risk Management.

## FUNDING: General Fund. DISCUSSION / BACKGROUND

Over the last several years the state has been moving towards evidence based practices as the standard for programs and services. The Probation Department's service delivery model is built on an

evidence-based practices framework, which has been proven through the scientific study of operant conditioning and social learning as an effective tool to influence behavior change in an offender population. The Carey Group, Inc. focuses on providing personnel, services, training materials, and books, as-needed to provide training, guidance, and consulting services to probation staff in using and implementing Case Planning and Motivational Interviewing programs. The Carey Group Inc. will also provide personnel and services necessary to provide consulting services for policy development and to monitor the Probation Department's alignment with evidence based practices. These strategies, when employed with fidelity, are proven to positively impact recidivism in the offender population, thereby reducing victimization in the community.

Staff is requesting the Board of Supervisors make findings that it is more economical and feasible to contract with The Carey Group, Inc. for as-needed specialized training services. The Probation Department is currently working with The Carey Group, Inc. to provide adequate training to specific Probation staff to become trainers in Case Planning and Motivational Interviewing. The Department intends to utilize these trained facilitator staff members to provide trainings to staff internally in the future.

The training provided by The Carey Group, Inc., supports the Probation Department in our mission to provide public safety through collaborative partnerships and innovative practices in corrections with accountability and compassion.
