On February 28, 2017, the Board endorsed an updated matrix for FY 2017-18 (Agenda Item 31, Legistar File 16-0069, Attachment Revised 2B).

On November 7, 2017, the Planning and Building Department Director presented the Board with a reformatted matrix for FY 2017-18 (Agenda Item 36, Legistar File 16-0069, Attachment 3A).

On June 12, 2018, the Board endorsed an updated Matrix for FY 2018-19 (Agenda Item 34, Legistar File 18-0865, Attachment Revised 2B).
