### DISCUSSION / BACKGROUND

In 2016, the State of California passed the Voter's Choice Act, Senate Bill 450 (SB450), allowing counties to conduct elections by vote-by-mail (VBM) ballot while also providing regional Vote Centers to be open 10 days prior to Election Day through close of voting on Election Day.

In order to determine voters' interest in this new Vote Center model, the Registrar and staff have presented the Vote Center model to several community organizations receiving very positive feedback. Additionally, the elections department assembled a Voting System Selection Committee (VSSC) comprised of various members of the community and county staff to select a new voting system. That committee was also introduced to the vote center model and unanimously voted in favor of El Dorado County adopting the Voter's Choice Act.

The Elections Department also completed a cost benefit analysis to determine the fiscal impact to the County and found the new voting system cost utilizing the Vote Center model will cost approximately

48% less (\$600,000) than a precinct model, while the cost of running an election will be approximately 2.5% higher (\$7,000 per election). There are changes being proposed to the VCA that would reduce the cost of running elections in El Dorado County over time. There is also a movement at the state Legislature that will transition the state to the VCA model.

The Legislation requires one (1) - 3 day vote center for every 50,000 voters (requiring 3 in El Dorado County), and one (1) - 4 day Center for every 10,000 voters (requiring a total of 13 vote centers in El Dorado County). Additionally, the County is required to provide one (1) Ballot Drop Box per 15,000 voters (requiring 9 in El Dorado County).

The VCA model provides benefits and a better voting opportunity to the voters of El Dorado County by providing more opportunities to vote. Every voter receives a mail ballot (we currently already mail ballots to ~ 80% of voters), they can return that ballot by postage-paid mail, drop their ballot at any Vote Center or Drop Box, vote at any Vote center up to 10 days prior to election day, or conditionally register to vote and vote at any Vote Center.

On March 3, 2019 the Board authorized the Elections Department to include in the 19-20 Recommended Budget an appropriation of \$1,514,000 with up to \$757,000 General Fund match (50%) for the purchase of a new voting system. (Legistar 19-0250)

#### **ALTERNATIVES**

The Board could not authorize the implementation of Vote Centers, thereby resulting in the current precinct model for elections. A new voting system will still be needed, but the purchase cost would be 48% (\$600,000) higher.
