DISCUSSION / BACKGROUND

The Surveyor's Office received an application from Buckeye Union Elementary School District, a political subdivision of the State of California, for an Irrevocable Offer of Dedication for Road Right of Way, Landscape and Public Service Easement (IOD) on Assessor's Parcel Number 119-100-011, and being more particularly described in Exhibit A and depicted on Exhibit B of the attached Exhibits. This dedication is to remain in effect and run with the land until such time as the Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution. Said dedication is in support of the Bass Lake Hills Specific Plan.

ALTERNATIVES

An alternative would be to not accept the IOD. By utilizing this alternative, the County or developers would be unable to meet improvement obligations of the Bass Lake Hills Specific Plan.
