The Surveyor's Office received an application from Jean Dolores Wyckoff, trustee of the Jean Dolores Wyckoff Revocable Trust, for an Irrevocable Offer of Dedication for Road Right of Way (IOD) on Assessor's Parcel Number 119-080-010, and being more particularly described in Exhibit A and depicted on Exhibit B of the attached Exhibits. This dedication is to remain in effect and run with the land until such time as the Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution and is in support of the Bass Lake Hills Specific Plan.

An alternative would be to not accept the IOD. By utilizing this alternative, the County or developers would be unable to meet improvement obligations of the Bass Lake Hills Specific Plan.
