Request to consider Conditional Use Permit CUP18-0013/AT&T CAF II Project (South Placerville) submitted by AT&T Mobility (Agent: Epic Wireless-Jared Kearsley) to allow the construction and operation of a 160-foot high monopine wireless communication facility within a 40-foot x 45-foot enclosed area. The property, identified by Assessor's Parcel Number 096-120-72, consisting of 10.16 acres, is located on the north side of Jim Hill Road, approximately 2,400 feet west of the intersection with Fort Jim Road, in the Placerville area, Supervisorial District 3.
