DISCUSSION / BACKGROUND

Surveyor's Office received an application (IOD 18-001) from El Dorado Hills Memory Care LLC, an Oregon Limited Liability Company, for a Pedestrian Access Easement on Assessor's Parcel Number 124-140-033, being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. The grant is for a perpetual easement for constructing, reconstructing, repairing, and forever maintaining a public sidewalk.

ALTERNATIVES

An alternative would be to not accept the dedication. By utilizing this alternative, the applicant would not be able to meet Condition of Approval #14 as established for PD15-0003.

OTHER DEPARTMENT / AGENCY INVOLVEMENT

Department of Transportation Division has reviewed said Pedestrian Access Easement and supports the consent to and acceptance of this Offer, subject to the condition that said Pedestrian Access Easement will not be County maintained.
