#### **DISCUSSION / BACKGROUND**

On May 14, 2019, the Board directed staff to return to the Board with a funding agreement in order to award \$1,700 to the City of Placerville to support their efforts to celebrate the Amgen Tour as it raced through El Dorado County.

A funding agreement is required in order for the County to process the payment to the City of Placerville. Approval of the funding agreement also provides the finding that a public benefit is derived from supporting this community event, which enhances tourism and encourages a sense of community to the people of El Dorado County.

#### ALTERNATIVES

The Board could choose not to approve the funding agreement, and no funding would be provided in support of these efforts.
