BACKGROUND

At their meeting of April 11, 2019, the Veteran Affairs Commission discussed amending their bylaws to add a member of the Board of Supervisors to the membership of the commission. The proposed revised section 2 of the bylaws is shown below.

Proposed Amendment to Section 2 of the Bylaws (as provided by the commission)

- 2. Appointment: Pursuant to El Dorado County Ordinance Code Section 2.20.520, the commission shall consist of the following members:
- A. Primary members: six Primary members shall be appointed by the Board of Supervisors. Five of the Primary members shall have been honorably discharged veterans of the U.S. Armed Forces; each of these shall be residents of El Dorado County and shall be nominated by a member of the County Board of Supervisors to represent his/her supervisorial district. One Primary member shall be a member of the County Board of Supervisors, selected by that body. In the event of a tie vote, the member of the County Board of Supervisor's vote shall not be counted, in order to break the tie.
- B. Alternate members: five Alternate members shall be appointed by the Board of Supervisors. Each shall have been honorably discharged veterans of the U.S. Armed Forces. Each of these shall be residents of El Dorado County and shall be nominated by a member of the County Board of

Supervisors to represent his/her supervisorial district. Alternate members may vote when the Primary veteran member, representing his/her district, is absent.

- C. Ex-officio members: The County Veterans Service Officer or his/her designee shall serve in an ex-officio, non-voting and advisory capacity on the Veterans Affairs Commission.
- 3. Quorum: A quorum shall be established when three voting members of the commission are present.
