On March 20, 2018, the Board of Supervisors approved the Chief Administrative Office, Parks Division enter into an Agreement for Services (Contract Number 2072) with Whitney Environmental Consulting, Inc., doing business as Foothill Associates, to provide regulatory consulting services for the permitting of the Sacramento-Placerville Transportation Corridor (SPTC) natural trail from Latrobe Road to Railroad Park and Railroad Park east to Missouri Flat Road. The contract is for a total not to exceed amount of \$70,932 and is for the term of March 20, 2018 and will expire on March 19, 2020.
