(a) Flag Lot 8: Increase allowed narrow access portion of flag lot from 100 feet to 232 feet in length; and

(b) Asphalt Dike: Allow Woodleigh Lane to remain Asphalt Dike in lieu of Concrete Curb and Gutter along project frontage

## **DISCUSSION / BACKGROUND**

Request to consider Tentative Subdivision Map TM17-1532/Sierra Sunrise submitted by Pacific States Development Corporation to allow a Tentative Subdivision Map to create seven single-family lots ranging in size from 17,329 to 21,779 square feet, one single-family lot of approximately 261,280 square feet, and one roadway lettered lot; and a waiver of El Dorado County Design and Improvement Standard Manual to include the following modifications of subdivision road improvement Standard Plan 101B: (a) Flag Lot 8-increase allowed narrow access portion of flag lot from 100 feet to 232 feet in length; and (b) Asphalt Dike-allow Woodleigh Lane to remain Asphalt Dike in lieu of Concrete Curb and Gutter along project frontage. The property, identified by Assessor's Parcel Numbers 116-030-28 and 116-030-30, consisting of 10 acres, is located on the east side of Woodleigh Lane, approximately 2,000 feet southeast of the intersection with Bass Lake Road, in the Cameron Park area, Supervisorial District 2.
