#### **DISCUSSION / BACKGROUND**

As part of Objective 2.2 of the Good Governance Goal in the Board approved Strategic Plan, Board policies are undergoing a review/update process. On February 13, 2018, the Board of Supervisors adopted updates to Board of Supervisors Policy K-1 - Injury Illness and Prevention Program. The proposed addition would be an effort to maintain an acceptable lighting range for County office work environments. Departments will continue to have the flexibility to accommodate the different needs/preferences of the employees working in office work environments as long as they provide sufficient lighting for safety and energy conservation.

The specific language addition includes the following on page 176 of attachments A and B: The Board of Supervisors Policy A-18, Energy Conservation Policy, states the maximum illumination levels for County of El Dorado offices to be 50 foot candles. Cal/OSHA requires a minimum illumination of .5 foot candles for office environments; however this does not provide adequate lighting for work. The minimum recommended illumination levels in an office setting are 20 foot candles, which is consistent with common best practice. Offices may regulate their lighting to the preferences and comfort of those working in the area, as long as the illumination levels remain between 20-50 foot candles.
