Background: The Procurement and Contracts Division processes various contracts with multiple laundry and linen service providers. Multiple contracts are necessary as not all vendors provide the same laundry and linen services and garment, linen, and accessory rental services.

Reason for Recommendation: Your Board is being asked to make findings that it is more economical and feasible to obtain an outside contractor to provide laundry and linen services County wide, rather than to create new County job classifications and obtain the specialized equipment and facilities necessary to perform the services.

On February 27, 2008 the Purchasing Agent executed Agreement for Services #623-S0810 with Ameripride Services for a total not to exceed amount of \$10,000.00 for the period of March 31, 2008 through March 31, 2010. Amendment I increased the not to exceed amount to \$50,000.00. Amendments II, and III provided for updated fee schedules.

Procurement and Contracts processed Amendment IV to said Agreement increasing the compensation by an additional \$50,000.00 for a total not to exceed \$100,000.00 for the remaining term of the Agreement.

Action to be taken following Board approval: Following Board approval, Board Clerk's Office will forward executed amendment to Procurement and Contracts for distribution, administration and encumbrance as needed.
