DISCUSSION / BACKGROUND

The Chief Administrative Office, Facilities Division, received a request from the Veteran's House Council to refinish the floors in the Veterans Memorial Building. This request was reviewed and approved by Health and Human Services. Funding for the project is available in the Veterans House Council special revenue fund. This fund receives \$15,000 annually from the General Fund to be used for maintenance and building improvement projects at the Veterans Memorial Building.

This project is not currently included in the proposed ACO work plan. Facilities is ready to proceed with the work once the Board approves the project and associated budget transfer. The project includes grinding the existing floor, repairing all cracks and installing two coats of commercial grade epoxy flooring.

ALTERNATIVES

The Board could choose not to approve the project and the floors will not be refinished.
