### DISCUSSION / BACKGROUND

A request has been submitted by Mohammadreza Dastoori and Sahar Anjomshoaa, owners of Assessor Parcel Number (APN) 124-120-012, requesting that the County of El Dorado, Board of Supervisors, vacate a portion of a public utility easement located on the subject property. Said easement is more particularly described in Exhibit A, and depicted on Exhibit B, of the attached Resolution.

The public utility easement, as shown on Lot 12 of The Promontory Village No. 2, recorded at Book I of Subdivisions at page 135, was offered to the County of El Dorado by Reynen and Bardis (Promontory), LLC, a California Limited Liability Company, on May 9, 2002, and Russell-Promontory, LLC, an Illinois Limited Liability Company, on March 28, 2002. The easement was acknowledged and accepted by the County of El Dorado on September 10, 2002, and the Subdivision Map recorded on September 11, 2002.

### ALTERNATIVES

An alternative would be to not adopt Resolution of Abandonment of Easement 19-0004. By utilizing this alternative, the owner of Assessor Parcel Number 124-120-012 would be unable to pursue any development that would impact this easement.
