DISCUSSION / BACKGROUND

On August 27, 2019, the Board authorized the Parks Manager to accept donations on behalf of the County for the Rubicon Trail (Legistar #19-1092). Since that date, many donations have come forward and due to the number of donations staff would like to recognize the organizations and individuals for their generosity. These donations will go towards building a Ford F550 pumper truck. A budget transfer has been attached to recognize donations as revenue and increases appropriations to fund the improvements on the truck. This budget transfer reflects the donations received to date and anticipates the amount of donations to still be received as revenue in fiscal year 19/20.

The donations will go towards building a Ford F550 pumper truck that has been donated by Sacramento Municipal Utility District (SMUD). The truck will be used as the base of the fabrication. SMUD has provided the attached donation agreement to the County in order to transfer the vehicle to the El Dorado County Parks Division.

The Parks Division is currently in the process of executing a contract with a vendor, WFO Concepts, for a six month term and a maximum contractual obligation of \$70,000 to provide fabrication services to construct a pumper truck for the Rubicon Trail. The contract is within purchasing agent approval authority but has been attached to this item for informational purposes.

WFO Concepts has specialized skills required to fabricate a pumper truck for the use on the Rubicon. This vendor has built the Jeep used by the County for maintenance purposes and has built the pumper trailer which will be used as the backup method for waste disposal.

On April 2, 2019, the Board approved a budget transfer for fiscal year 18/19 in the amount of \$25,000 for the purchase of a pumper trailer through WFO Concepts (Legistar #18-1891). The vendor began fabrication of the trailer after the approval of this item and the issuance of a purchase order; however, the trailer has not yet been completed. The attached budget transfer will carry over the funding for the pumper trailer from fiscal year 18/19 to fiscal year 19/20.

ALTERNATIVES

The Board could choose not to approve the budget transfer. This option risks a violation from the State Water Quality Control Board and possible closure of the trail.

FINANCIAL IMPACT

There is no fiscal impact with the donations. Any County expenses related to the donations, or plan to service the restrooms, will come back to the Board for consideration and approval.

The cost of the \$25,000 trailer would be funded through the State Off-Highway Vehicle funds, with no impact to the General Fund. This funding was previously approved by the Board on April 2, 2019. The approval of this budget transfer will carry over this funding.

The potential financial impact of a violation of the sanitation plan is \$10,000 per day fine.
