**DISCUSSION / BACKGROUND**

The Surveyor's Office received an application from James B. Greenwalt and Susan M. Greenwalt, as Trustees Of The Greenwalt Family Trust Initially Established on June 21, 2001, for a Road Right of Way (In Fee) and Slope Easement and a Drainage Easement on a portion of Assessor's Parcel Number 115-040-010, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This IOD is in support of the Bass Lake Specific Plan.

### **ALTERNATIVES**

An alternative would be to not accept the Irrevocable Offer of Dedication. By utilizing this alternative, the County or developers would be unable to meet improvement obligations of the Bass Lake Specific Plan.
