### DISCUSSION / BACKGROUND:

Health and Human Services Agency (HHSA) recommending the Board accept new funding from the California Department Aging (CDA) to provide fall prevention service programs.

On January 31, 2020 HHSA received the Dignity at Home Fall Prevention Program Grant Agreement FP-1920-29 for the purpose of providing fall and injury prevention information, education, referral services, equipment, assessments, services, materials and labor costs to the eligible service population. For acceptance of this Grant, the signed documents are due back to CDA as soon as

possible, and HHSA worked to get the item on the soonest possible Board date.

Fall Prevention Program funding is intended to target services and activities specific to individuals who meet the following criteria: (1) Age sixty (60) or have disabilities, (2) whose adjusted household income does not exceed 80 percent (80%) of the area median income, and (3) who are at risk of falling or institutionalization.

**ALTERNATIVES:**

The Board could choose to not accept the additional funding, thereby eliminating this Fall Prevention Program funding from the Senior Services programs funding opportunities.
