Sheriff's Office recommending the Board authorize the Chair to sign a Funding/Reimbursement Agreement between El Dorado County Sheriff's Office (EDSO) and El Dorado County Office of Education (EDCOE), where EDSO purchased two (2) vehicles for School Resource Officers working at EDCOE schools.

**FUNDING:** Reimbursement from El Dorado County Office of Education.

### DISCUSSION / BACKGROUND

The use of School Resource Officers (SROs) has been a valuable resource to the schools in El Dorado County. In order to make sure the SROs have necessary equipment it was determined that vehicles outfitted specifically for the SROs would be purchased by EDSO and costs up to \$100,000 would be reimbursed by EDCOE prior to the end of FY19/20.

These vehicles will be owned and maintained by the Sheriff's Office through County Fleet for the duration of their lifetime and will be used by SROs during that timeframe allowing for both EDSO and EDCOE to benefit from this agreement. The cost to purchase the two vehicles is estimated at \$90,000, plus an additional \$18,000 to equip the vehicles. The unreimbursed amount will be covered by General Fund within the Sheriff's Office.
