Amplified music for each event would be limited to the hours of 6:00 pm to 10:00 pm on weekdays and 12:00 pm to 10:00 pm on weekends and holidays. The property, identified by Assessor's Parcel Number 331-113-013, consisting of 0.46 acres, is located on the north side of Pleasant Valley Road at the intersection with State Route 49, in the El Dorado area, Supervisorial District 3.
