The Surveyor's Office received an application from Kailash C. Chaudhary, Trustee and Gisela D. M. Chaudhary, Trustee of the Kailash and Gisela Chaudhary Revocable Trust UTD August 25, 2004, for a Road Right of Way (In Fee) on Assessor's Parcel Number 119-100-047, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This IOD is in support of the Bass Lake Specific Plan.
