DISCUSSION / BACKGROUND

Department of Transportation (Transportation), recommending the Board adopt and authorize the Chair to sign a Resolution accepting the 2019 revisions to the County of El Dorado Maintained Mileage System, which does not provide for any changes or revisions to the County of El Dorado 2018 Maintained Mileage System.

There were no changes to mileage based on field or office review of actual road parameters. The proposed Resolution and accompanying updates to the County system will be submitted to the State of California, pursuant to the Streets and Highways Code, Section 941 and Section 2121.

ALTERNATIVES

Without the Board's approval of this Resolution, the update would not be accepted by the State and would adversely affect future State funding. Additionally, the County would not meet the requirements of Streets and Highway Code Section 2121 that mandates submission of changes to the County system in May of each year.
