DISCUSSION / BACKGROUND

The Surveyor's Office received an application from Wally Cheplick A Married Man, As His Sole And Separate Property for an IOD (IOD 20-0001) for Road Right Of Way and Public Service Easements on Assessor's Parcel Number 119-090-021, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. These dedications would allow for future road right of way and public service easements on Assessor's Parcel Number 119-090-021 and satisfy the conditions of approval for the Bell Ranch Subdivision, which requires the construction of Morrison

Road that crosses the subject property.
