Department of Transportation recommending the Board approve and authorize the Chair to sign a budget transfer adjusting the budget for Fiscal Year 2019-20 to allow for the transfer of additional revenues in the Road District Tax account to the Road Fund.

FUNDING: Road District Tax Revenues.

DISCUSSION / BACKGROUND

Department of Transportation

Revenues for Road District Tax (RDT) received in Fiscal Year (FY) 2019-20 are higher than budgeted. This budget transfer will allow the additional revenue received to be transferred to the Road Fund.

Budgeted appropriations for RDT need to be increased in Operating Transfers Out by \$500,000, offset by an increase to Property Taxes Secured in the amount of \$500,000.

Budgeted appropriations for Transportation - General Department need to be increased in Operating Transfers In: RDT by \$500,000, offset by an increase to Appropriation for Contingency in the amount of \$500,000.

ALTERNATIVES

The Board may elect not to approve the budget transfer as proposed, although proper accounting for the Road Fund would be jeopardized.
