DISCUSSION / BACKGROUND

A request has been submitted by Alan Douglas O'Dell and Carol Jeanne O'Dell, Trustees, or their successors in trust, under The O'Dell Trust dated November 14, 2012, owner of Assessor's Parcel Number 025-754-001, 025-754-002 and 025-754-003, requesting that the County of El Dorado, Board of Supervisors, vacate a portion of a public utility easement located on said property. Subject easement is more particularly described in Exhibit A and depicted on Exhibit B of the attached Resolution.

The public utility easements, as shown on Lot 50, 51 and 52 of Montgomery Estates Unit No. 4 at Lake Tahoe, was offered to the County of El Dorado by Montgomery Developers, Co-Partnership By: Sunrise Builders, A California Corporation; David D. Bohannon Organization, A California Corporation; By: Pacific Highlands Inc. A California Corporation, on December 2, 1965. The easement was acknowledged and accepted by the County of El Dorado on December 13, 1965, and the Subdivision Map was recorded on December 14, 1965.
