DISCUSSION / BACKGROUND

Since June of 2006, the Probation Department (Probation) has been contracting with AutoMon, LLC (AutoMon) for a proprietary case management system called Caseload Explorer, which includes modules for adult supervision, juvenile supervision, juvenile detention facilities, and fiscal; licensing; installation; maintenance; escrow; training; customization; and system upgrades.

Since the initial contract with AutoMon, Probation has added services to include product subscription and service of AutoMon's Ce Connect Licensed Software Products and Modules. These product systems allow for managing drug-testing, providing flexible client reporting, and managing all phases of pretrial.

AutoMon provides software support for its software products. AutoMon has recently completed

services for integration of Noble Software Group's proprietary assessment service with Caseload Explorer and the Ce Connect Products. This professional service, while part of the Scope of the Agreement, was not factored into the original Compensation/Not to Exceed amount of the Agreement.
