#### **DISCUSSION / BACKGROUND**

This represents the second annual report of real property acquisitions pursuant to Ordinance 5094. For this annual reporting period of July 1, 2019, through June 30, 2020, only real property acquisitions for approved Capital Improvement Projects have been executed.

During this period, the Department of Transportation (Transportation) Right of Way Unit acquired twenty-one (21) individual acquisitions for a total cost of \$122,200, ranging from \$1,000 to \$24,500 per acquisition. Please refer to Attachment A for the current annual report, which provides an itemization of each acquisition's associated capital project, funding, parcel or easement cost, and purpose.

#### PRIOR BOARD ACTION

On April 5, 2016 (Item 23), the Board approved Ordinance 5037 which delegated to the Community Development Agency (CDA) Director the authority to acquire any interest in or easement upon real property of \$25,000 or less in value as part of the approved Capital Improvement Program. On April 18, 2017 (Item 6), the Board approved Ordinance 5051 thereby reorganizing the CDA and delegating signature authority to the Chief Administrative Officer, or designee.

On August 15, 2017 (Item 13), the Board approved Ordinance 5056 which delegated to the Director of Transportation the authority to acquire any interest in or easement upon real property for the purposes of a public structure, road, trail, or improvement as previously approved by the Board or as part of the approved Capital Improvement Program, with the delegated authority limited to real property acquisitions of \$25,000 or less in value. This Ordinance became effective on September 14, 2017.

On October 9, 2018 (Item 17), the Board approved Ordinance 5094 which requires an annual report to the Board of real property acquisitions, instead of the previous reporting requirement of twice a year. This ordinance became effective on November 8, 2018.

On September 17, 2019 (Item 20), Transportation presented the first annual report for the reporting period of June 1, 2018 through June 30, 2019 under Ordinance 5094.

#### OTHER DEPARTMENT / AGENCY INVOLVEMENT

Transportation staff work with County Counsel to facilitate acquisitions on an as-needed basis.

#### **CAO RECOMMENDATION**

#### FINANCIAL IMPACT

These real property acquisitions were made using various funding sources as detailed in Transportation's Capital Improvement Program, as described in Attachment A. There is no fiscal impact or Net County Cost associated with this item.
