Chief Administrative Office, Facilities Division recommending the Board:

- 1) Authorize and approve the Chief Administrative Officer to sign and execute Facility Use Agreement 5195 with the El Dorado County Office of Education (EDCOE) for the use of the Senior Center located at 990 Lassen Lane, El Dorado Hills to provide an extended day care and learning facility for the children of the El Dorado Union High School District employees effective upon execution through December 31, 2020;

- 5) Approve and authorize the Chair to sign Amendment II to Joint Use Agreement 303-01511 with El Dorado Hills Community Services District (CSD) suspending the requirement of the CSD to pay for their portion of utilities and maintenance cost for the use of the Senior Center premises during the period of time that EDCOE is occupying the space.

**FUNDING:** EDCOE has agreed to pay for cost of all utilities at the site during their term of use.

### **DISCUSSION / BACKGROUND**

The El Dorado County Office of Education (EDCOE) manages over twenty day care sites for the children of essential workers in El Dorado County. The teachers and district employees at Oak Ridge High School have agreed to go back to work effective October 8, 2020. Students of those employed by the Oak Ridge High School (grades kindergarten through sixth grade) will need a day care space and learning facility Monday through Friday from 7:00 am to 6:00 pm.

Currently, El Dorado Hills CSD has a Joint Use Agreement (JUA) with the County for shared use of the El Dorado Hill Senior Center. During the time that EDCOE will be occupying the space, the CSD will not be required to pay their share of the utilities and maintenance cost for the premises.

The Division recommends approval of this Facility Use Agreement and amendment to the Joint Use Agreement No. 303-01511 with El Dorado Hills CSD. Use of this space as described will provide a public benefit.

### **ALTERNATIVES**

EDCOE could rent commercial office space that would be time consuming to process and more costly to them.
