## **DISCUSSION / BACKGROUND**

In preparation for increased need for vaccine storage / deployment due to the COVID-19 pandemic, the Health and Human Services Agency (HHSA) Public Health Nursing Program is requesting to purchase a vaccine refrigerator. The equipment is medical quality and required to maintain the required temperature for vaccine during storage. As with all the current COVID-related purchases, we are competing with many other entities for the same products and request to move forward with the purchase to allow our county to be prepared when the COVID vaccine is deployed.

### **ALTERNATIVES**

Disapproval of this Budget Transfer Request could result in insufficient vaccine storage thereby limiting the County's ability to respond to community need for vaccinations in 2020-21.
