## **DISCUSSION / BACKGROUND**

Request to consider Conditional Use Permit CUP19-0013/Planned Development PD19-0006/Better Place Forest submitted by BETTER PLACE FORESTS to request a 48-acre memorial conservation forest and scattering grounds with associated site improvements including a 250-foot paved access driveway, 16 parking spaces, a 711 square foot visitor center, a 571 square foot accessory structure and walking trails. The property, identified by Assessor's Parcel Numbers 101-240-045, 101-220-002, and 101-220-003, consisting of 48 acres, is located on the east side of Blair Road, approximately 4,700 feet north of the intersection with Pony Express Trail, in the Pollock Pines area, Supervisorial District 5.
