Title: Health and Human Services Agency recommending the Board:

1) Approve and authorize the Chair to sign Amendment II to Agreement for Services 4206 with Progress House, Inc., for the provision of Drug Medi-Cal Organized Delivery System (DMC-ODS) Services, increasing the not to exceed amount by \$60,000 for a new maximum obligation of \$1,828,247, with no change to the term of the Agreement;

2) Make findings in accordance with County Ordinance 3.13.030 that it is appropriate to contract with Progress House, Inc. for services provided under this Agreement 4206 because (B) "Specialty skills and qualifications not expressly identified in classifications are involved in the performance of the work;" and

3) Authorize the Purchasing Agent, or designee, to execute further documents relating to Agreement for Services 4206, including amendments which do not increase the maximum dollar amount or term of the Agreement, and contingent upon approval by County Counsel and Risk Management.

DISCUSSION / BACKGROUND:

On May 23, 2017, the Board authorized the County to "opt in" to the Federal 1115 Waiver for a Drug Medi-Cal Organized Delivery System (DMC-ODS).

On April 30, 2019, the Board approved Funding Agreement 18-95146 with California Department of Health Care Services, which allowed the County to move forward with the DMC-ODS Waiver plan and begin contracting with Drug Medi-Cal (DMC)-certified service providers. By opting in to participate in this program, the County is obligated to establish sufficient capacity to meet the needs of the target population. In accordance with the requirements of the DMC-ODS funding Agreement, the County must comply with 42 Code of Federal Regulations (CFR) Section 438.207 and maintain a network of providers that is sufficient in number, mix, and geographic distribution to meet the needs of the anticipated number of beneficiaries in the service area.

DMC-ODS services are expanded beyond those previously provided, as demonstrated below:

Benefits available from both the DMC-ODS Waiver Benefits as well as (prior) standard Drug Medi-Cal Benefits:

- 1) Outpatient Services
- 2) Intensive Outpatient Services
- 3) Narcotic Treatment Program Services

Additional benefits available from the DMC-ODS Waiver:

- 1) Residential Treatment services through DMC-ODS have no bed limitation and multiple levels of care; however, standard DMC Benefits are limited to perinatal clients in facilities with less than 16 beds.
- 2) Withdrawal Management services through DMC-ODS is a continuum of care; however, standard DMC Benefits are limited to Inpatient Hospital Detoxification.
- 3) Recovery Services, Case Management, Physician Consultation, Additional Medication-Assisted Treatment, and Partial Hospitalization benefits are provided through DMC-ODS; however, none of these services are provided by standard DMC Benefits.

On July 10, 2018, HHSA initiated a Request for Qualifications (RFQ) 19-918-004 on July 10, 2018 to ensure standardized service agreements for DMC-ODS providers that meet the requirements of the DMC-ODS funding. This RFQ remains open to maximize the opportunity to contract with DMC-certified service providers to meet the need of clients in El Dorado County.

On April 21, 2020, the Board approved Agreement 4206 with Progress House, Inc. to provide DMC-ODS services. Subsequently, on October 20, 2020, the Board approved Amendment I to Agreement 4206.

Amendment II is an adjustment due to allocating more AB109 funding in other provider contracts and less in Progress House's contract in expectation that it would match the usage of the contracts.

Amendment II is required to continue authorization and provision of non-DMC services at Progress House for Probation referred clients. Non-DMC Services include recovery residences (formerly called transitional housing); drug testing. Services for non-DMC eligible AB109 clients include case management, withdrawal management, residential and outpatient treatment, and gap coverage.
