On April 5, 2021, the Chief Administrative Office received an email from the office of Caltrans District 3 requesting the County's support of a nomination for the 2021 American Association of State Highway and Transportation Officials (AASHTO) America's Transportation Awards for the Echo Summit Sidehill Viaduct Replacement project.

America's Transportation Awards helps showcase why transportation infrastructure - and why properly funding it - is vital to supporting the nation's economy while improving the quality of life for communities across the country. The competition serves as a way to recognize state departments of transportation and highlights the projects they deliver that make their communities a better place to live, work, and play.
