# **DISCUSSION / BACKGROUND**

Surveyor's Office received an application from RCP Saratoga, LLC, a California Limited Liability Company, for an IOD (IOD 21-0002) for a Pedestrian Easement on Assessor's Parcel Number 120-690-012, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This dedication would provide for a future sidewalk and possibly the widening of Saratoga Way. The final determination will be made by the Transportation Department during the design process for RCP Construction Office and Parcel Map (DR 20-0003/ P20-0004).

#### **ALTERNATIVES**

An alternative would be to not accept the IOD. By utilizing this alternative, no provision would be made for providing the future sidewalk as is required by the Transportation Department as condition No. 2 of the project RCP Construction Office and Parcel Map (DR 20-0003/ P20-0004).
