Title IV-E of the Social Security Act (Title IV-E) allows local governments to claim partial reimbursement for specified activities undertaken for youth in foster care, youth at risk for removal from their homes, and youth in general. Title IV-E provides support for payments on behalf of eligible children, as well as funds for related case management activities, training, data collection, and other costs of program administration. Administrative funding is calculated based on Probation Officer documentation of time spent on the specified activities. Claims are based on time studies completed for each calendar quarter.

Since August 14, 2019, Justice Benefits, Inc, (JBI), has provided professional assistance specific to Title IV-E administrative claims, time study software, and assists in exploring new state funding opportunities for Probation.
