DISCUSSION / BACKGROUND

The County of El Dorado (El Dorado) has established Juvenile Detention Facility(ies) (JDF) for the temporary or long-term commitment of youth detained in accordance with the provisions of the California Welfare and Institutions Code.

The County of Modoc Probation Department (Modoc) desires to place youth of its Juvenile Court in an El Dorado JDF, to the extent that accommodations exist. Rates payable to El Dorado are \$125 per day per bed or \$150 per day per bed for the Juvenile Treatment Center Challenge Program.
