### DISCUSSION / BACKGROUND

El Dorado County Ordinance Code, Title 5, Section 5.14.070, Business Taxes, Licenses and Regulations - Fortunetelling, states:

" A. No license may be issued without the express authorization of the Board of Supervisors. The Board may limit the number of licenses issued to such number as in its judgment will serve the public health, safety and welfare.

" B. Within 30 days after an application is made, the Sheriff shall file a written report with the Board of Supervisors stating his or her recommendations regarding issuance of the license."

The Sheriff Department's recommendation for approval is attached to this Item as Attachment A.

Currently there are three active business licenses for fortunetelling/psychic reading in the unincorporated areas of El Dorado County.
