**Fiscal Impact/Change to Net County Cost:** This grant is providing 100% funding and there is no County match requirement.

**Background:** On June 16, 2009, your Board approved agenda item # 09-0712 allowing the Sheriff to submit the 2009 Homeland Security Grant Application. The Sheriff's OES division has been approved for this grant.

The Fiscal Year 2009 Homeland Security Grant program has allocated \$225,105 for the State

Homeland Security Grant Program (SHSP) and \$228,310 for the Law Enforcement Terrorism Prevention Program (LETPP), for a total grant amount of \$453,415 to El Dorado County for the FY 2009 Homeland Security Grant program. The County is the subgrantee and provides funding for planning, equipment, training, exercises and management and administration costs to the Cities of South Lake Tahoe and Placerville, Sheriff's Office, Public Health, Environmental Management, Fire Districts and other eligible local government agencies.

**Reason for Recommendation:** El Dorado County applies for this grant annually and has again been approved for grant funding. The Sheriff's Office recently received the grant award letter and is bringing this item back to your Board with a Budget Transfer establishing a budget.

As required by the Homeland Security Grant, the County Board of Supervisors created an Approval Authority, representing the Cities of Placerville and South Lake Tahoe, Sheriff, Fire Districts, and Public Health on April 8, 2003, to distribute the grant funds at the local level. This Approval Authority met and allocated the grant funds to equipment, planning, training, and management and administration of the grant.

With regard to grant purchased equipment, the County, as the Operational Area lead agency, will purchase and loan equipment to other participating agencies, or subgrant funds to the agencies to purchase equipment, and eventually transfer ownership of the equipment to participating agencies after grant audits are completed.

Additional action is requested to list equipment, allocated by the Approval Authority, on the Sheriff's Office Fixed Asset List.

**Action to be taken following Board approval:** After Board approval, the Auditor's Office will enter the Budget Transfer into the County's system. Sheriff's Department will submit reimbursement claims to Cal EMA as the funds are expended.
