Background/Reason for Recommendation: An independent outside consultant specializing in

The representation and advice provided by this law firm relating to employment and labor matters have proven professional and thorough. The term of the agreement is for the period of one year and not to exceed \$25,000. This amount is included in the FY 2009/10 Budget.
