# FUNDING: General Fund. DISCUSSION / BACKGROUND

Human Resources engaged the Law Offices of Amy Oppenheimer in February 2020 to perform professional employment services including, but not limited to, investigations, trainings, and services related to other various employment-related subjects. The department has decided to extend the agreement by two years, making this a four (4) year contract. Amendment II adds an additional \$3,606 to the not to exceed amount of the contract and revises the rate structure with increased rates for some attorney classifications between ten and thirty percent. Per Policy C-17, Board approval is required for any agreement term exceeding three (3) years inclusive of any amendments and regardless of dollar amount.
