DISCUSSION / BACKGROUND

The funds are made available through the Help American Vote Act and will be used for things such as approved voting systems and components, voter education, official/vote center training, storage, warehousing and electronic communications between county and vote centers. The agreement of \$11,239.97 reflects the remaining amount allocated to El Dorado County Elections HAVA 301 funds and extends the agreement.

The funds are available upon approval authorizing the Registrar of Voters to sign agreement through January 18, 2025.
