Surveyor's Office received an application from Russell-Promontory, LLC An Illinois Limited Liability

Company, for an IOD (IOD 21-0005) for a Public Utility Easement on Assessor's Parcel Number 124-390-013, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This dedication would provide for a Public Utility Easement on Assessor's Parcel Number 124-390-013.
