#### **DISCUSSION / BACKGROUND**

These funds are made available through the State of California as part of the Voter's Choice Act (VCA) implementation. The funds will be used for voter outreach and education related to the Gubernatorial Primary Election to be held on June 7, 2022 and the Gubernatorial General Election to be held on November 8, 2022. The term of this agreement is upon approval through May 1, 2023 for expenses incurred after January 1, 2022 and prior to November 8, 2022.

The total agreement is for \$70,000, with the budgeted amount of \$35,000 allocated for the Primary Election (Fiscal Year 2021-22) and \$35,000.00 allocated for the General Election (Fiscal Year 2022-23). The allocated amount for the General Election has been requested for inclusion in the Fiscal Year 2022-23 budget.
