DISCUSSION / BACKGROUND

In June 2021, the Board of Supervisors approved a contract with Surveillance Systems Incorporated

(SSI) to consolidate, standardize, and improve upon the support and to comply with State retention regulations as it relates to video storage (Legistar Item 21-0683).

The Recorder-Clerk had an analysis performed and SSI identified the need for 8 cameras (7 for Placerville office and 1 for South Lake Tahoe office).
