**Title:** Health and Human Services Agency (HHS) recommending the Board:  
1) Make findings in accordance with County Ordinance 3.13.030 that it is appropriate to contract with Summitview Child and Family Services, Inc. for the provision of Student Outreach and Engagement Centers and Mental Health Support services, provided under Agreement 6491 because (B) "Specialty skills and qualifications not expressly identified in classifications are involved in the performance of the work;"  
2) Approve and authorize the Chair to sign Agreement for Services 6491 with Summitview Child and Family Services, Inc., with a not-to-exceed (NTE) amount of \$150,000, and for a term effective July 1, 2022 through June 30, 2023; and  
3) Authorize the HHS Director or the Director of Behavioral Health to execute further documents relating to Agreement 6491 including amendments, contingent upon approval by County Counsel and Risk Management, which do not increase the maximum dollar amount or term of the Agreement.

### DISCUSSION / BACKGROUND:

In 2004, California voters passed Proposition 63, the Mental Health Services Act (MHSA). MHSA imposes a one (1) percent tax on personal income in excess of \$1,000,000. The funds from the tax are distributed to California counties and are intended to transform the Mental Health System into

one that is consumer and family driven, recovery-oriented, accessible and culturally competent, and a system that offers services appropriate for the population that is served. MHSA requires counties to prepare a MHSA Three-Year Program and Expenditure Plan (Plan). The Plan has five (5) components intended to address specific goals for priority populations and other key community mental health needs, which are Prevention and Early Intervention (PEI), Community Services and Supports (CSS), Innovation (INN), Workforce Education and Training (WET), and Capital Facilities and Technology Needs (CFTN). Each year, Counties are required to follow a formal process for providing an annual update to the Plan, which requires Board approval. The purpose of the Annual Update is to review the Plan's existing projects and, based upon their status or other identified needs, to make additions, modifications, or deletions to the Plan.

On June 9, 2020, the Board adopted and authorized implementation of the MHSA Fiscal Year 2020-21 through 2022-23 Three-Year Program and Expenditure Plan (File 20-0446). Included in the Three-Year Program and Expenditure Plan is the Student Outreach and Engagement Centers and Mental Health Supports (Student Wellness Centers) project. Services provided in the project include mental health screenings, assessments, individual mental health clinical services, outreach and engagement, and linkage to County and community services. This two-year pilot project was set to end on June 30, 2021, however as youth in El Dorado County may experience varying mental health ramifications related to the coronavirus pandemic, community support for continuing the project continued to grow. As such, throughout the Community Program Planning Process for the most recent MHSA Fiscal Year (FY) 2021-22 Annual Update, community stakeholders continued voicing their endorsement and support of the Student Wellness Centers project and recommended it be extended to help meet this anticipated need, expanding it to also include the provision of services in middle schools. After analyzing the prospect of continuing and expanding the program, it was determined to meet criteria for continuation and the FY 2021-22 MHSA Annual Update (File 21-0713) adopted by the Board of Supervisors on June 22, 2021, included this project.

The Health and Human Services Agency (HHSA) currently contracts with Sierra Child & Family Services, Inc. to provide Student Wellness Centers within the El Dorado High School District via Agreement 5463, approved by the Board on June 29, 2021. This proposed Agreement 6491 with Summitview Child and Family Services, Inc. (SVCFS) is for SVCFS to provide a Student Wellness Center at a minimum of one middle school within the El Dorado County Office of Education school districts. SVCFS will be working directly with the Office of Education to determine the location based upon factors including but not limited to particular student populations with higher anticipated service needs.

In accordance with Board of Supervisors Procurement Policy C-17, Section 7.11, the contractor selection process for service contracts in excess of \$100,000 must include a review of the scope of services and contractor's professional qualifications by a group of individuals (including at least one representative from outside the department requesting the services) qualified to judge the contractor's ability to perform the services. HHSA has documentation on file that such a review was performed for Agreement 6491 with Summitview Child and Family Services, Inc.

#### **ALTERNATIVES:**

Should the Board decline to approve this recommendation, this MHSA project would be delayed until HHSA could vet another contractor willing and able to provide the project services. The length of time such a process could take would make HHSA out of compliance with the MHSA Plan. Further, SVCFS already has established office space at middle schools within the district. It would be very difficult for a new contractor to obtain similar office space at the middle schools.
